## **Transfer of ownership / Registration**

Your ENCHANTED puppy will come with a 3 Generation Pedigree. The AKC/UKC registration application will stay with us (the breeder) until the puppy is paid in FULL. New owners will have 1 year from the date of issue of the application registration to register their puppy. AKC registration currently is \$20 and UKC registration \$16. There is a late fee after the 1 year. The registered name of the puppy MUST begin with "ENCHANTED". Once an ENCHANTED puppy, your puppy will always be an ENCHANTED puppy and must be registered as such to honor our guarantee.

If your puppy is sold as Show/breed quality puppy, FULL REGISTRATION shall be granted once Hip/Elbow OFA/Penn Hip are complete and we (the breeder) have obtained a copy of the certification from you (the buyer). No OFA results will be accepted before the age of 2 years. OFA ratings have to be Fair/Good or Excellent. Elbows have to be normal. This is to verify hips and elbows are acceptable for breeding. NO ENCHANTED puppy shall be bred BEFORE the age of 2 years. or this guarantee is VOID. You (the buyer) must pay the AKC fee to lift limited registration to full registration. If you allow your puppy to breed before 2 years of age we will seek legal action and repossess the puppy as we consider this irresponsible pet ownership and detrimental to the White Shepherd breed. The buyer will carry any legal fees. TO AVOID LEGAL ACTION – DO NOT ALLOW YOUR PUPPY TO BREED UNTIL YOU MEET OUR REQUIREMENTS!

If your puppy was sold as Pet Quality puppy, a COPY of LIMITED REGISTRATION papers will be given to you at time of FULL payment for the puppy. The puppy MUST be spayed or neutered and CANNOT be used for breeding under any circumstances. Please be a responsible pet owner and watch your puppy closely. Males can breed as early as 6 months and females usually come in heat by month 8. Please spay/neuter your puppy. You will be given the original registration papers after you (the buyer) shows us (the breeder) proof of spay or neuter from your vet. You (the buyer) are responsible for any registration late fees that might result from spaying or neutering your pet after 1 year has expired.

ALL ENCHANTED puppies come already micro-chipped. You (the buyer) agree that we (the breeder) shall remain on the micro-chip paperwork as an alternate contact. This is for the protection and safety of your ENCHANTED puppy. Should your puppy get lost or stolen, we may rescue your puppy and return him/her to you safely. You (the buyer) will always remain the MAIN contact on your puppy's micro-chip. We will provide you with the MC number and signed transfer for your ENCHANTED puppy's micro-chip.

## **Health Guarantee**

At ENCHANTED White Shepherds we have taken great care and thought into our breeding program. However, even with most care, some underlying genetic conditions might occur even of healthy parents. Your ENCHANTED puppy is guaranteed against genetic defects for a period of 3 years, which includes but is not limited to heart defects, deafness, blindness, EPI and Mega-Esophagus.

Your new ENCHANTED puppy is guaranteed to be healthy upon delivery. You (the buyer) have 3 days after receiving the puppy to have it examined by a veterinarian and provide us (the breeder) with the results. Your ENCHANTED puppy will have first vaccinations, a full exam by a veterinarian and will be wormed. We will provide you with a veterinarian certificate of health and all health records pertaining to your new ENCHANTED puppy. If your puppy is found to be unhealthy, you (the buyer) may return the puppy for a full refund or a replacement puppy of equal value. A signed diagnosis from the veterinarian must be provided. Puppy must be returned to the breeder before a refund is given. The buyer is responsible for all costs in returning the puppy and, if so chosen, receiving the replacement puppy. No cash refunds will be given after 3 days. After that the health of your puppy becomes your (the buyer) responsibility. We (the Breeder/Seller) strongly suggest you (the Buyer) make an appointment with your veterinarian PRYOR to your ENCHANTED puppy's arrival to his/her new home, to be examined within the 3 day health guarantee time limit. This is also the beginning of your ENCHANTED puppy's relationship with his/her new veterinarian and a chance for you to ask your veterinarian about any questions or concerns you may have.

Your ENCHANTED puppy is guaranteed against CRIPPLING HIP/ELBOW DISPLASIA for 30 months from date of birth. If your ENCHANTED puppy was sold as Breed/Show Quality (FULL REGISTRATION) he/she is guaranteed to PASS OFA/PENN HIP HIP/ELBOW CERTIFICATION. Hip and elbow X-rays MUST be taken and submitted to OFA/PENN HIP BEFORE your ENCHANTED puppy reaches the age of 2 1/2 years.

All guarantees apply to the original purchaser only and are NOT transferable. In the event you (the Buyer) wish to RETURN or COLLECT on this guarantee, we (the Breeder/Seller) reserve the right to a SECOND VETERINARIAN OPINION before we honor this guarantee and ALL veterinarian records MUST be supplied to us (the breeder/Seller) upon request.

## **New Owner Obligation**

Your ENCHANTED puppy is dependant up on you to give him/her the life he/she deserves, with care and love and being part of your family. Provide fresh clean water at all times. Provide nutritious food and a well balanced diet. Provide veterinarian care. Provide a fenced yard, kennel, with adequate shelter. Under NO circumstances should the puppy EVER be chained! Keep us (the breeder) up to date in changes of your address and phone number, also very important to micro-chip information. Keep us (the breeder) informed of your ENCHANTED puppy's life, health and a picture here and there would be greatly appreciated. If we get occasional updates it helps us stay updated with the genetics of the ENCHANTED puppy's and gives us piece of mind our puppy's are

happy and healthy. You (the buyer) are required to take an obedience /socialization class by the time your ENCHANTED puppy is 4-8 months of age. Obedience for your ENCHANTED Shepherd puppy is very important and essential for your puppy to become a behaved member of the family. It also gives you the special time to bond and get to know each other. We offer a \$50 rebate for your puppy earning the CGC title (upon receiving a copy of the AKC registered title) and a \$50 rebate for your dog receiving a Therapy Dog Certificate ( has to be held for at least 2 years).

If FOR ANY REASON you (the buyer) find you no longer can keep your ENCHANTED puppy, you MUST notify us (the breeder) immediately. We will work together with you to find an ACCEPTABLE new home for your ENCHANTED puppy. If an ACCEPTABLE new home cannot be found, we (the Breeder/Seller) will take responsibility of your ENCHANTED puppy until such time an ACCEPTABLE new home can be found. UNDER NO CIRCUMSTANCES IS AN ENCHANTED PUPPY TO EVER BE TAKEN TO A HUMAN SOCIETY, ANIMAL SHELTER, DOG POUND OR BE TURNED OVER TO ANY RESCUE ORGANIZATION!!!!!! Your (the Buyer) ENCHANTED puppy is not to be SOLD, TRADED, LEASED OUT or GIVEN AWAY without our (the Breeder/ Seller) knowledge and written consent for the ENTIRE life of your ENCHANTED puppy. You (the Buyer) further agree that you will NOT sell your ENCHANTED puppy nor ANY of its progeny to ANY AGENT, PET STORE, GUARD DOG BUSINESS or LABORATORY/RESEARCH FACILITY.

If we can document your (the Buyer) failure to keep these agreements you (the Buyer) have entered into with us (the Breeder/Seller), and so inform you through certified mail, you will have 72 hours to return your (the Buyer) ENCHANTED puppy to us (the Breeder/Seller) at your expense. If you (the Buyer) fail to do so , I shall have the LEGAL RIGHT to repossess your (the Buyer) ENCHANTED puppy and get SIGNED registration transfers from you WITHOUT refunding ANY money. With the HEALTH and WELFARE of our (the Breeder/Seller) ENCHANTED puppy FIRST and FOREMOST, NEGLECT/ABUSE to our (the Breeder/Seller) ENCHANTED puppy will result in IMMEDIATE repossession of our (the Breeder/Seller) ENCHANTED puppy with the aid of the proper authorities. In addition, you (the Buyer) shall be responsible for ANY/ALL expenses incurred in the process of repossession, including but not limited to ALL legal fees and veterinary care to restore the health of our (the Breeder/Seller) ENCHANTED puppy, if necessary.
